


DRIVEWAY APRON





Codes Administration and Public Works are taking a proactive approach to address the many driveway apron violations in the apartments in Denby Park. Over the summer, the landlords received letters of violation and were told that they must fix the aprons or be taken to court. Some of the apartment owners fixed the violations on their own. However, many landlords did opt to have the city bid out all of the work as one project and have a private contractor fix them. Each landlord wrote a check to the City to pay for the construction. This is a win-win for the neighborhood because the apron eyesores are gone and a local construction company hired workers to complete the job.

Surveillance Cameras	 Surveillance cameras were mounted and installed at Forth Worth Ave, Galveston Ave and San Antonio Boulevard. Later this month, the computer consultant will come back to town to train the PD how to view, retrieve and save data.

RESIDENTIAL AND REMODELING SERVICES MEETING

Norfolk Redevelopment & Housing Authority and the City of Norfolk have several loan and grant programs to help you create a "new home" look and feel. The Norfolk Home Rehabilitation Program for homeowners whose income meets NRHA guidelines to provide money for improvements to your home; The Residential Façade and Aesthetic Improvement Grant Program that provides a matching grant up to \$15,000 per property with 1-4 legal dwellings units for significant improvements to property; The Model Home Demonstration Program that provides a matching loan for the purpose of increasing living space; and the Neighborhood Street Stabilization Program Is an incentive for property owners to participate in the revitalization effort under which, the City will agree to provide infrastructure improvements to a whole improve add value to the neighborhood.


