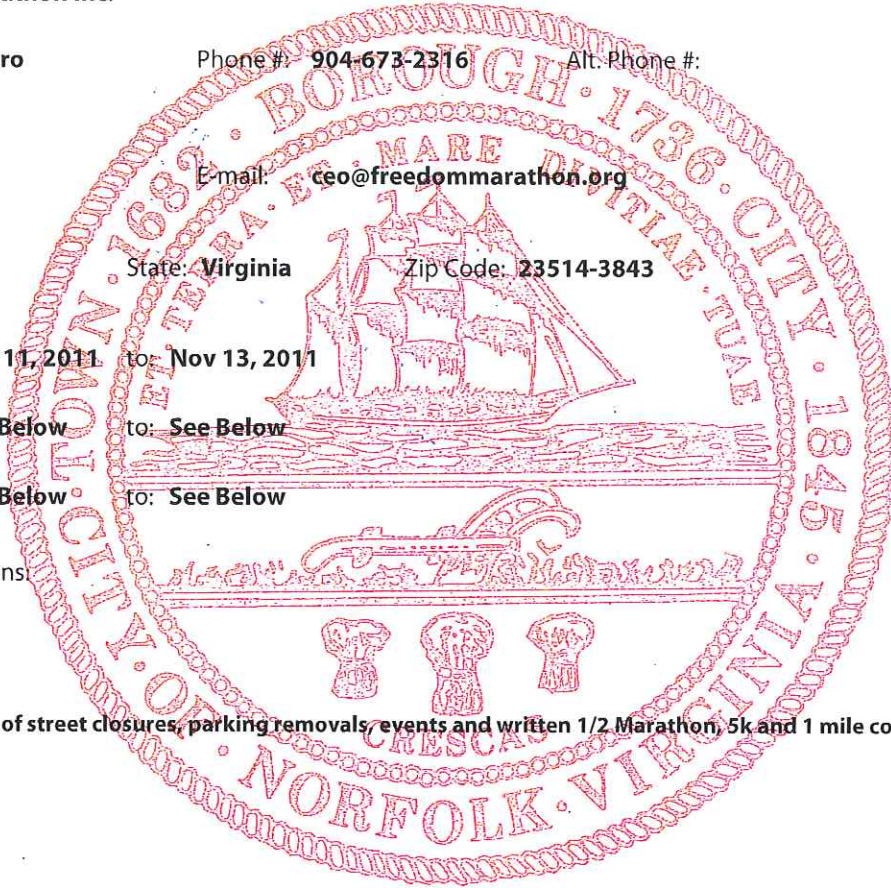

## Foot Race Permit Freedom Half Marathon Weekend Events

---

### FRIDAY, NOVEMBER 11, 2011

**PARKING REMOVAL:** Parking will be removed from Waterside Drive starting at 9AM. TOC will place signage for the removal 24 hours in advance and Parking will bag meters. Parking removal will remain thru the conclusion of event load-out on Sunday (11.13)

**STREET CLOSURE:** All lanes of Waterside Drive will be closed allowing local traffic only from Main Street to Atlantic Street starting at 12PM for event load-in. TOC will set closure and off-duty NPD officers will man closure. Local traffic access will be maintained on eastbound Waterside Drive to the Otter Berth parking lot for Spirit Cruises & to Waterside Marketplace for Fashion Week events. Full closure will remain thru the conclusion of event load-out on Sunday (11.13).

### SATURDAY, NOVEMBER 12, 2011

**EVENT:** Kid's Warrior Trot (Freedom Mile)  
**TIME:** 10AM – 11AM

**ROUTE / LANE CLOSURES:** Participants will gather on Waterside Drive west of Martin's Lane. Participants will proceed west on Waterside Drive to Main Street; make a u-turn at the intersection of Waterside Drive and Main Street and proceed east on Waterside Drive to St. Paul's Blvd.; make a u-turn at the intersection of Waterside Drive and Saint Paul's Blvd. and proceed west on Waterside Drive to Main Street; make a u-turn at the intersection of Waterside Drive and Main Street and proceed east on Waterside Drive to end at Town Point Park in accordance with attached map.

### SUNDAY, NOVEMBER 13, 2011

**STREET CLOSURE:** All lanes of Waterside Drive will be closed from Main Street to St. Paul's Blvd starting at 6AM. TOC will set all street closures for the Freedom ½ Marathon & Wounded Warrior 5k from Waterside Drive to Virginia Beach Blvd. Spivey Rentals will set all street closures north of Virginia Beach Blvd in accordance with attached map starting at 2AM. All closures and traffic stoppages will be under Norfolk Police control. As such, brief intermittent stoppages of The TIDE light rail vehicles (less than 2 minutes) may also be required under police control at the intersection of Boush Street and W. Bute Street and at the intersection of Saint Paul's Blvd. and E. Plume Street. Though The TIDE schedule does not include the event's hours, HRT may be positioning The TIDE light rail vehicles for daily operations during this time.

**PARKING REMOVAL:** Parking will be removed on southbound Granby Street from W. Little Creek Road to the Granby Street bridge and from northbound Boush Street from E. Main Street to College Place from 5AM – 11AM. TOC will place signage for the removal 24 hours in advance.

**MEDICAL TENTS:** Medical tents will be placed on City property in the following locations. All tents will be set and struck on Sunday (11.13). All other tent locations are on private property and are not included in this permit.

- (1) tent will be set in the northbound lanes of Martin's Lane at Waterside Drive. Access must be maintained to the parking garage.
- (1) tent will be set in the ROW adjacent to southbound Granby Street at Willow Wood.
- (1) tent will be set on 11<sup>th</sup> Street at Granby Street. Spivey Rentals will close 11<sup>th</sup> Street for this tent placement.

**WATER STATIONS / PORTOLETS:** Water Stations & portolets will be set on City property in the following locations. All water stations / portolets will be set and struck on Sunday (11.13) unless otherwise stated. All other water stations / portolets are on private property and are not included in this permit.

- Water Station / Portolets will be set on southbound Monticello Avenue at St. Paul's Blvd. / Monticello split. A Salvation Army truck will also be set at this location. The City will close Monticello Avenue for this placement.
- Water Station / Portolets will be set on Shirley Avenue between Llewellyn Avenue & Granby Street. Spivey Rentals will close Shirley Avenue for this placement.
- Portolets will be set on Waterside Avenue in the westbound parking lane after 12PM on Friday (11.11). They will be removed following the conclusion of the events on Sunday (11.13).

**EVENT:** Freedom ½ Marathon  
**TIME:** 7AM – 10:45AM

**ROUTE / LANE CLOSURES:** Participants will gather on Waterside Drive west of Martin's Lane. Participants will proceed west on Waterside Drive; continue in the northbound lanes on Boush Street to W. Brambleton Avenue; turn left onto W. Brambleton Avenue and proceed west in the curb lane to Hampton Blvd; veer right and proceed north in the curb lane to 26<sup>th</sup> Street; continue in the middle and curb lanes of Hampton Blvd to W. 45<sup>th</sup> Street; turn right on W. 45<sup>th</sup> Street and loop back to Hampton Blvd.; turn right on Hampton Blvd. and proceed north in the curb lane to W. Little Creek Road; turn right onto W. Little Creek Road and proceed east in the curb lane to Granby Street; turn right onto Granby Street and proceed south in the curb lane to Monticello Avenue; turn right onto Monticello Avenue and proceed south in the curb lane and onward to St. Paul's Blvd; stay left and proceed south in the curb lane to Waterside Drive; turn right and proceed west to finish on Waterside Drive at Martin's Lane. TOC and Spivey Rentals will set and secure all lane closures and NPD will ensure participant safety with special attention paid to the intersection of Saint Paul's Boulevard and Waterside Drive exit from I-264 in accordance with attached map..

**EVENT:** Wounded Warrior 5k  
**TIME:** 7:30AM – 8:45AM

**ROUTE / LANE CLOSURES:** Participants will gather on Waterside Drive west of Martin's Lane. Participants will proceed west on Waterside Drive; continue in the northbound lanes on Boush Street to W. Brambleton Avenue; continue north in the curb lane to E. Virginia Beach Blvd.; continue north in the curb lane of Llewellyn Avenue to Shirley Avenue; turn right onto Shirley Avenue and proceed east to Granby Street; turn right onto Granby Street and proceed south to E. 14<sup>th</sup> Street; turn left onto 14<sup>th</sup> Street and proceed east to Monticello Avenue; turn right onto Monticello Avenue and proceed south in the curb lane and onward to St. Paul's Blvd; stay left on Saint Paul's Boulevard and proceed south in the curb lane to Waterside Drive; turn right onto Waterside Drive and proceed west to finish on Waterside Drive at Martin's Lane. TOC and Spivey Rentals will set and secure all lane closures and NPD will ensure participant safety with special attention paid to the intersection of Saint Paul's Boulevard and Waterside Drive exit from I-264 in accordance with attached map.

**All participants must be off the course by 10:45 AM. Any participants on race course after 10:45 AM must move out of the roadway and onto sidewalks and adhere to all traffic signals. Street sweepers will fall in behind the last participants to sweep the streets. TOC, NPD and Parking Enforcement will remove traffic control and re-open closed roadway sections as soon as the street sweeper passes. Trash along the route will be picked up by Waste Management.**
